Undertaking in the form of affidavit, from the person deployed to this effect shall be required to be submitted by the Service Provider.
- 16. The Service Provider must be registered with the concerned Govt. Authorities, i.e. Labour Commissioner, provident Fund Authorities Employees State Insurance Corporation etc. and a copy of registration should be submitted. The Service Provider shall complete with all the legal requirements for obtaining License under Contract Labour (Regulations and Abolition) Act, 1970 if any, at his own part and cost, if required under the Act.
- 17 The Service Provider shall provide a substitute well in advance if there occurs any probability of the person leaving the job due to the his/her own personal reasons. The payment in respect of thee overlapping period of the substitute shall be the responsibility of the Service Provider. The Service Provider shall be responsible for contribution towards provident Fund and Employees State Insurance, wherever applicable.
- 18 The persons deployed by the Service Provider should have good police records and no criminal case should be pending against them
- The persons deployed should be polite, cordial and efficient while handling the assigned work and their actions should promote good will and enhance the image of the **Principal Government Industrial** actions should promote good will and enhance the image of the **Principal Government Industrial**Training Institute (ITI) Chandahandi, Nabarangpur. The Service Provider shall be responsible for any act of indiscipline on the part of the persons deployed.
- 20 The persons deployed shall during the course of their work to be privy to certain qualified documents and information which they are not supposed to divulge to third parties. In view of this, they shall be required to take Oath of confidentiality and breach of this condition shall make the service provider as well as the person deployed liable for penal action under the applicable laws besides, action for breach of contract.
- The Service Provider shall be responsible for compliance of all statutory provisions relating to minimum wages as payable to different types of workers in respect of the persons deployed by it in the **Principal Government Industrial Training Institute (ITI) Chandahandi, Nabarangpur.** The **Principal Government Industrial Training Institute (ITI) Chandahandi, Nabarangpur** shall have no liability in this regard.
- 22 The Service Provider shall also be liable for depositing all taxes, levies, cess etc. on account of service rendered by it to the **Principal Government Industrial Training Institute (ITI) Chandahandi, Nabarangpur** to the concerned tax collection authorities, from time to time, as per the rules and regulations in the matter. Attested Xerox copies of such documents shall be furnished to the **Principal Government Industrial Training Institute (ITI) Chandahandi, Nabarangpur.**
- 23 The Service Provider shall maintain all statutory registers under the Law and shall produce the same, on demand, to the authority of Principal Government Industrial Training Institute (ITI) Chandahandi, Nabarangpur or any other authority under law.
- The Tax deduction/GST deduction as per rules at Source (TDS/GST) shall be done as per the provisions of Income Tax Act/Rules as amended, from time to time and a certificate to this effect shall be provided by **Principal Government Industrial Training Institute (ITI) Chandahandi, Nabarangpur.**
- In case, the Service Provider fails to comply with any liability under appropriate law and as a result thereof, the **Principal Government Industrial Training Institute (ITI) Chandahandi, Nabarangpur** is put to any loss/obligation monetary or otherwise, the **Principal Government Industrial Training Institute (ITI) Chandahandi, Nabarangpur** will be entitled to get itself reimbursed out of the outstanding bills or the performance security Deposit of the Service Provider, to the extent of the loss or Delegation in monetary terms.
- The agreement is liable to be terminated because of non-performance, deviation of terms and conditions of contract, non-payment of remuneration of employed persons and non-payment of statutory clues. the **Principal Government Industrial Training Institute (ITI) Chandahandi, Nabarangpur** will have no liability towards non-payment of remuneration to the persons employed by the Service Provider and the outstanding statutory dues of the service provider to statutory authorities. If any loss or damage is caused to the **Principal Government I T I, Chandahandi, Nabarangpur** by the person deployed, the same shall be recovered from the unpaid bills or adjusted from the performance security Deposit.

- 27 In case of breach of any terms and conditions attached to this agreement, the performance security deposit of the Service Provider shall be liable to be forfeited beside annulment of the Agreement.
- 28 The Manpower Service Provider shall raise the bill, along with signatures of all Manpower and certification by concerned officer as a proof that payments to all have been made by Contractor in the presence of concerned Officer. On monthly basis, the contractor should submit the bill (in triplicate) along with photocopies of (Wages and attendance) registers for that' month as prescribed under minimum wages Act, and authenticated proofs for payment of (EPF, ESI) with ECR & GST in respect to all Manpower's latest by 7th of the following month duly certified by the concerned officer, for payment as per different tender's terms-conditions. The contractor shall submit the bill by 10th of the month.
- 29 As far as possible the payment will be released by the last date of the succeeding month.
- 30 The amount of penalty calculated @ 100 per day on account of delay, if any, in providing a suitable substitute for the period beyond three working days by the Manpower Service Provider shall be deducted
- 31 The Authority reserves the right to withdraw or relax any of the terms and condition mention above so as
- 32 In the event of any dispute arising in respect of the clauses of the agreement of the same shall be resolved through negotiation. Alternatively the dispute shall be referred to the next higher authority or controlling office for his decision and the same shall be binding on all parties.

33 All disputes shall be under the jurisdiction of Chandahandi/Nabarangpur only.
